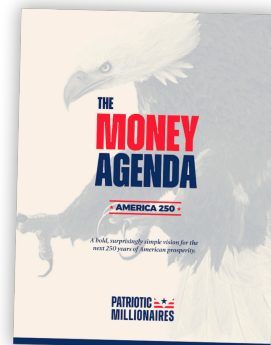
Tax the Rich. Pay the People. Spread the Power. Save America.

 "In my experience assisting ultra wealthy clients, their concern over taxation was limited to how it impacted their wealth. Unlike for most Americans, tax obligations for the ultra rich don't impact life decisions. Some ultra rich clients of mine opted out of tax avoidance. It just didn't enhance their quality of life. That's important. Limiting tax avoidance by the ultra rich won't keep their kid from attending college, delay their retirement, or inconvenience them in any way. They won't even have to sell their yacht to pay their taxes. They will never want for anything."
